2025/2026 Rental Rates

- -Practice Ice: \$100 + HST= \$113.00 per sheet per hour. (This fee is for NON-MEMBERS).
- -Ice & Lounge Rental
 - -Option #1 (Rent four ice sheets for 8 ends or less and use of the lounge/kitchen for 2 hours): -\$300 + HST = \$339.00.
 - -Option #2 (same as Option #1 but for groups of 14 people or less):
 - -\$20 + HST = \$22.60/person (fee does not apply to members participating in the rental).
 - -Option #3 (same as Option #1 but for more than one 8-end game [ex= 2 games of 6 or 8 ends]): -\$37.50 + HST = \$42.38 per end
 - *Bar may be available with enough notice to arrange for a bartender at a rate of \$20/hour.
 - **SMART SERVE is required for members to open the bar when renting the facilities otherwise above fee applies.

Rental Agreement

A non-refundable deposit of \$100 is required to secure the rental. The rental fee balance will be determined according to the current fee schedule and must be paid in FULL prior to the event.

The club may be accessed for decorating purposes the evening prior to the function providing there is no other rental or league play and will not impact the cost of the rental fee. This excludes the use of glitter, confetti and or rice.

The club is to be vacated with all decorations removed following the completion of the function. Damage costs may be charged to the renter if excessive damages occur during the function.

The renter is responsible for general cleanup of the kitchen and lounge area to the state it was in prior to their rental. All food and materials must be removed from the kitchen and the facilities left clean including sweeping of the floor, garbage bagged and removal of surface grease.

The renter is responsible for the proper care of all equipment and dishes within the kitchen area. Additional costs may be added for missing or damaged articles.

The Palmerston Curling Club reserves the right to designate staff to attend all rentals to ensure all terms and regulations are being observed and respected.

Alcoholic beverages are only permitted in the licensed area (lounge) and must not be served to minors.

No outside alcohol may be brought into the facility NO EXCEPTIONS

Liability Waiver provided at the club must be completed for all participants before entering the ice area.

Ice Rentals must use clean soft soled shoes with good grip on the ice. Footwear must be cleaned prior to entering the ice area.

Helmets are mandatory for players under the age of 12 and must be brought in by the player/renter.

The Palmerston Curling Club in no way will be held liable for damage, injury, accident or loss occurred during the rental agreement.
